#### Re: 2015 LEAP Emergency Financial Assistance & Winter Warmth Results

This letter provides an update on the results of the Ontario Energy Board's (OEB) Low-Income Energy Assistance Program ("LEAP") Emergency Financial Assistance ("EFA") and Winter Warmth programs reported by electricity and natural gas distributors for 2015. For the complete results see Attachment A to this letter.

The LEAP EFA and Winter Warmth programs are two of several programs available to lowincome customers. In November 2015, the OEB announced the launch of the Ontario Electricity Support Program (OESP) which provides monthly, on-bill credits to bill payers who meet the Statistics Canada Low Income Measure. The OESP, together with LEAP, Winter Warmth, low-income targeted conservation incentives and special customer service rules are designed to assist and protect consumers having difficulty making bill payments.

#### 2015 LEAP Results – Electricity Distributors

On April 30, 2016, electricity distributors filed their annual LEAP EFA results for 2015, as part of the OEB's Reporting and Record Keeping Requirements. A snap shot of the 2015 results with a comparison against 2014 is shown in the table below:

Some additional highlights:

- There was \$1,298,009 in remaining funds to be carried forward for use in 2016, in addition to the distributors' 2016 LEAP EFA funds.
- Social agency partners for 13 utilities did not charge administration costs.

#### 2015 LEAP Results – Natural Gas Distributors

On April 30, 2016, the natural gas distributors filed their annual LEAP EFA and Winter Warmth results (as applicable) for 2015. In 2015, Union Gas had adequate funding from its court settlement to provide emergency financial assistance through the Winter Warmth program. This program will be replaced by the LEAP EFA Program in 2016 as Winter Warmth funds run out. Since 2012, Enbridge Gas has delivered funds through the LEAP EFA program.

The highlights of the combined results of LEAP EFA and Winter Warmth programs are shown in the table below. For a full breakdown of the LEAP EFA and Winter Warmth results, see Attachment A to this letter.

Natural gas utilities had a balance of \$91,161 in LEAP EFA and Winter Warmth funds remaining which were carried forward for use in 2016.

Most electricity distributors and Enbridge Gas also filed monthly monitoring data which captures demographic information about the applicants. The information, which has been collected annually, is fairly consistent each year. Consequently, in 2015, the OEB changed the frequency of reporting this information to once every three years – the next reportable year will be 2018.

- According to the monthly monitoring data, the typical LEAP applicant is a renter, living in a house.
- The methodology used to calculate the average monthly income and average arrears was changed in 2015 from a simple average to a weighted average. In 2015, the weighted average monthly income of applicants was \$2,167 (\$1,901 in 2014) and the weighted average amount in arrears was \$1,225 (\$598 in 2014).

### LEAP EFA Program Overview

- The Low-Income Energy Assistance Program Emergency Financial Assistance (LEAP EFA) is a grant program intended to provide emergency relief to eligible low income customers who may be experiencing difficulty paying their bills.
  - Not intended to provide regular or ongoing bill payment assistance
- LEAP EFA is funded by distributors' ratepayers through the distribution rate of each utility.
- Distributors contribute the greater of 0.12% of their total Board-approved distribution revenue, or \$2,000.
  - Up to 15% of funding may be retained for agency administration fees.
- Social agencies are responsible for screening for eligibility, as per criteria and guidelines set out in the LEAP EFA Program Manual.
- Maximum of \$500 per fuel, per household, per calendar year
  - \$600 maximum amount for electrically heated homes



#### Winter Warmth Program Overview

- Union Gas Limited and Enbridge Gas Distribution Inc. were subject to separate court settlements that required them to contribute to the Winter Warmth program.
- Winter Warmth (WW) is a low-income assistance program designed for natural gas consumers.
- The Winter Warmth framework was used in the development of LEAP EFA.
- Enbridge, having depleted its Winter Warmth funds by May 2012, delivered LEAP EFA funds in 2014 and 2015.
- In 2015, Union Gas continued to deliver the Winter Warmth program but there was just over \$91,000 remaining by year-end. As a result, Union Gas began the transition to LEAP in 2016.



### Distributors Participating in LEAP EFA in 2015

- 78 distributors participating in LEAP EFA & Winter Warmth:
  - 73 Electricity distributors
  - 5 Natural gas distributors
    - Enbridge Gas, Union Gas, Natural Resource Gas (NRG), Utilities Kingston, Kitchener Utilities
- 145 social service agencies participating in LEAP EFA & Winter Warmth program delivery:
  - 70 lead agencies delivering LEAP EFA in the electricity sector
  - 75 agencies delivering LEAP EFA & Winter Warmth in the natural gas sector
